Floor Plan



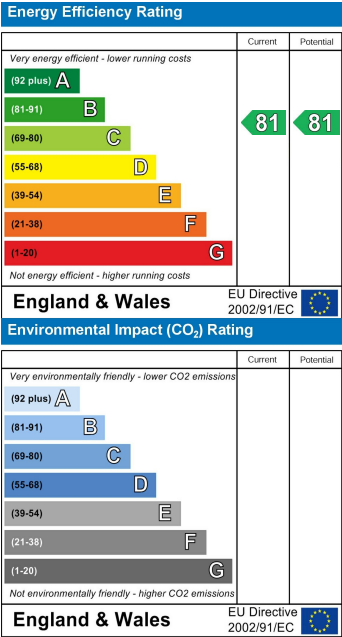
