DESCRIPTION

Wonersh House has recently undergone a major refurbishment, providing Grade A, fully connected, office space. The building is one of four buildings on The Guildway Office Park, overlooking an idealistic nature setting whilst only a 5-minute drive from Guildford town centre.

The building benefits from a new internal cafe amenity with an offering of artisan coffee, fresh pastries, and lunchtime paninis.

The refurbishment includes new VRF air conditioning with exposed services, new fully accessed raised floor, new LED intelligent strip lighting and an onsite car parking ratio of 1:185 sq ft.
