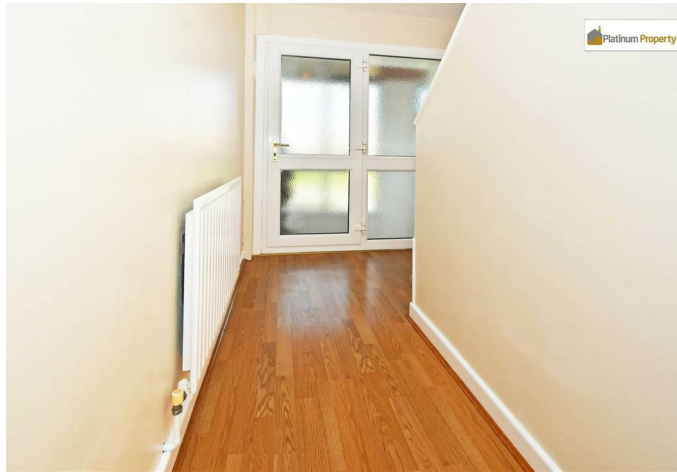

Location Map

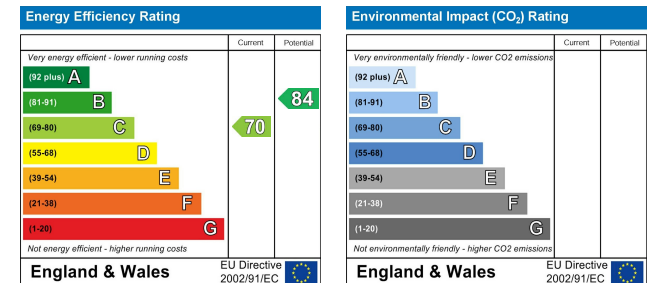
