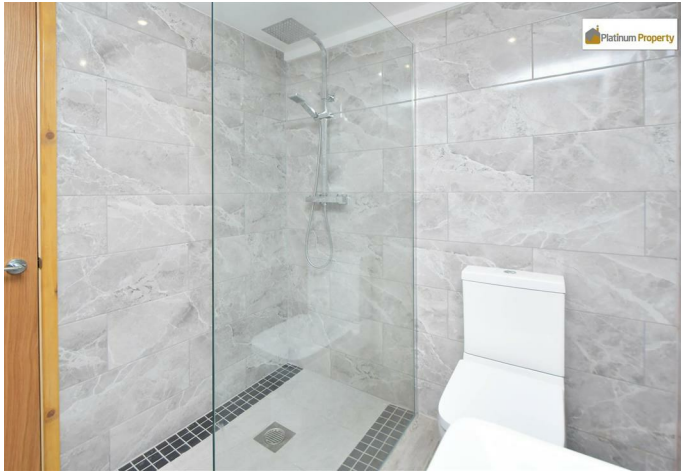

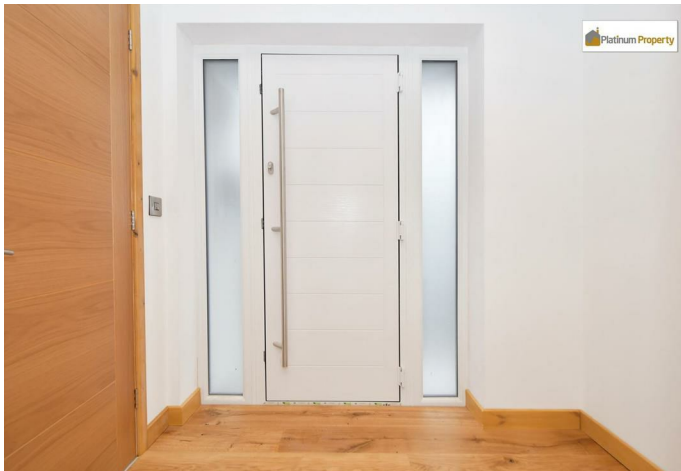

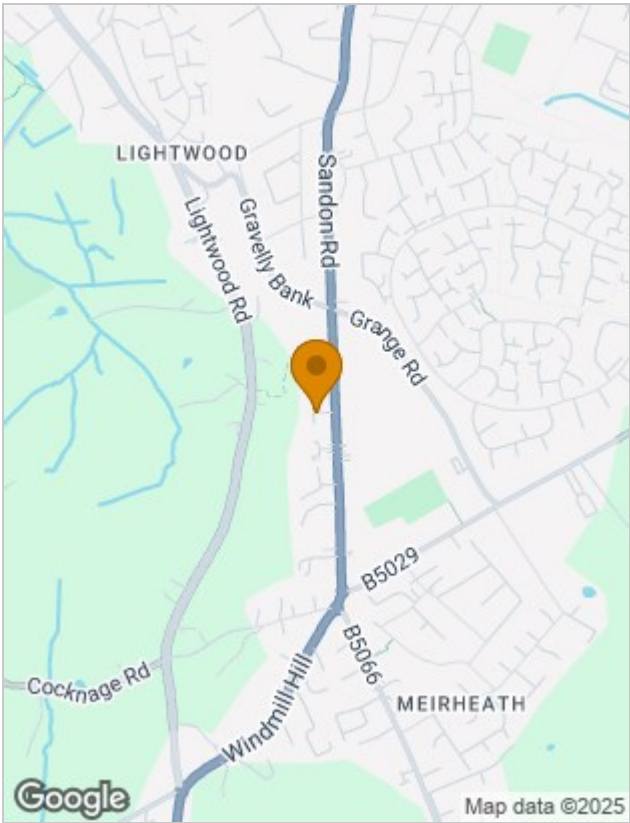

Location Map

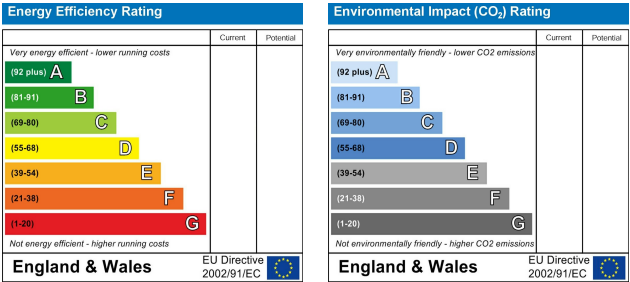
