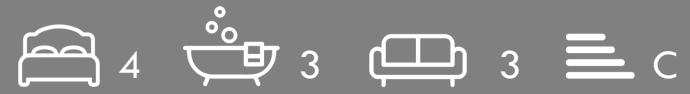

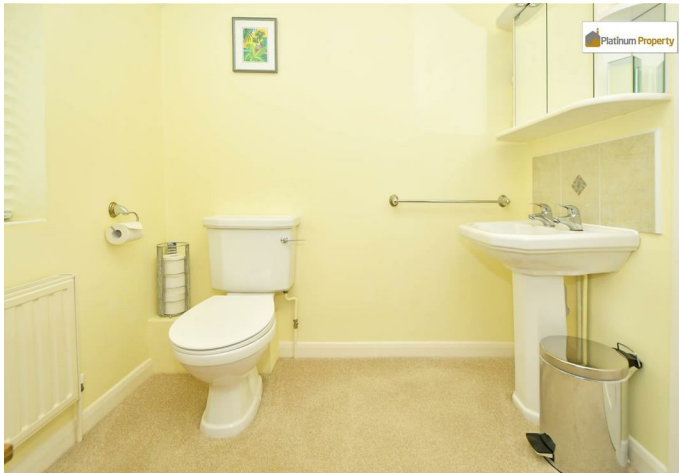

Location Map

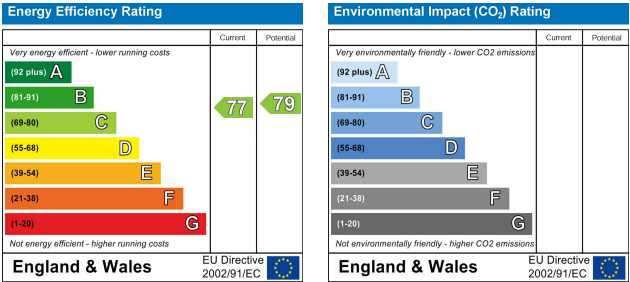
