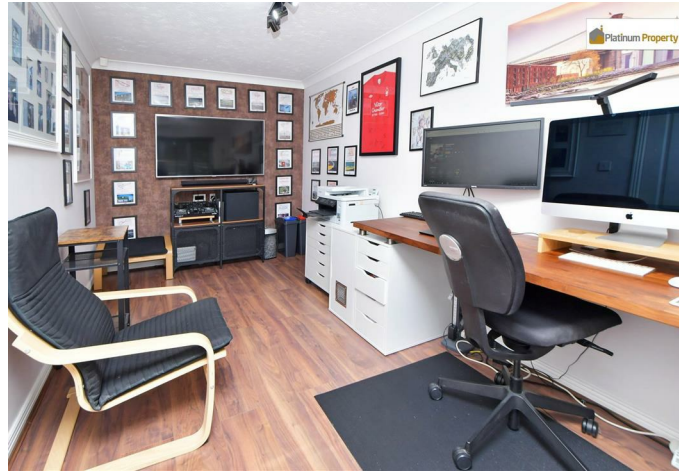

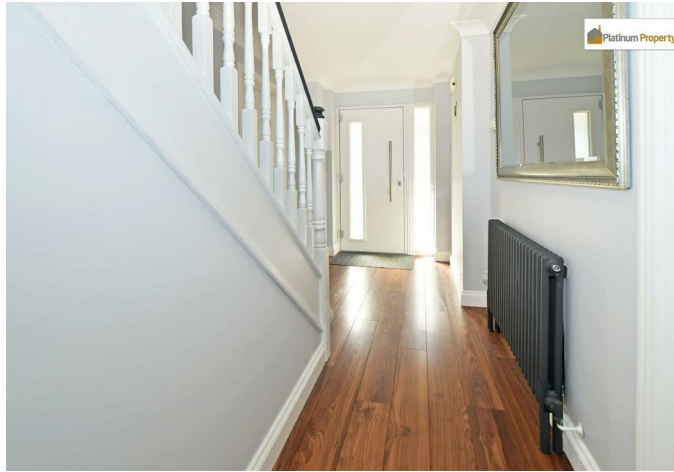

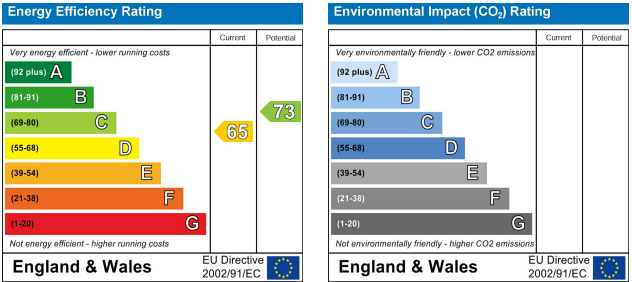
First Floor
