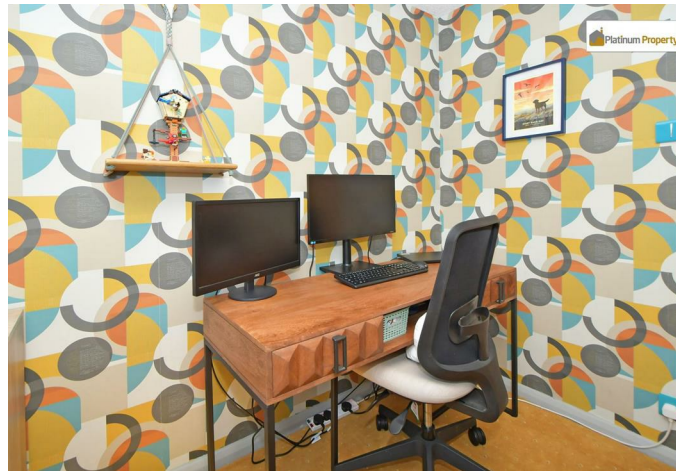

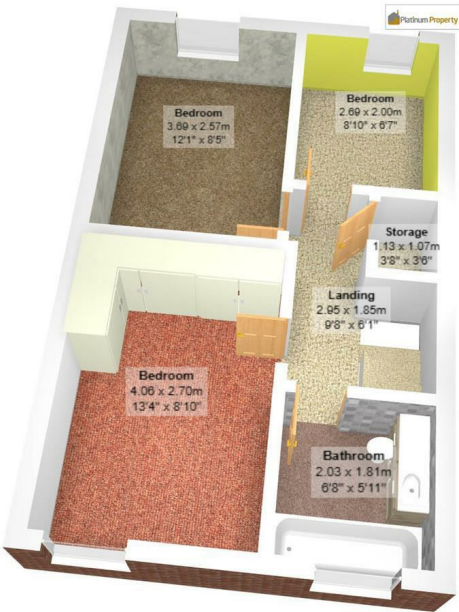

Floor Plans

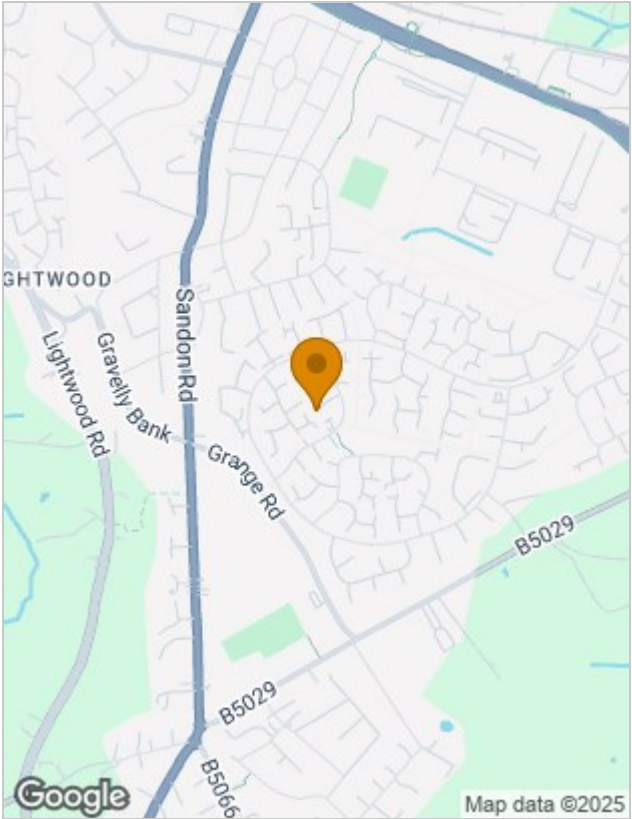


Ground Floor

Location Map



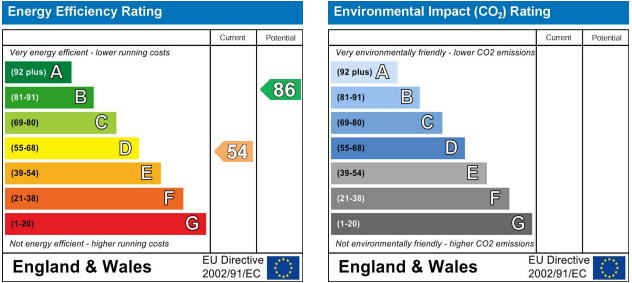
