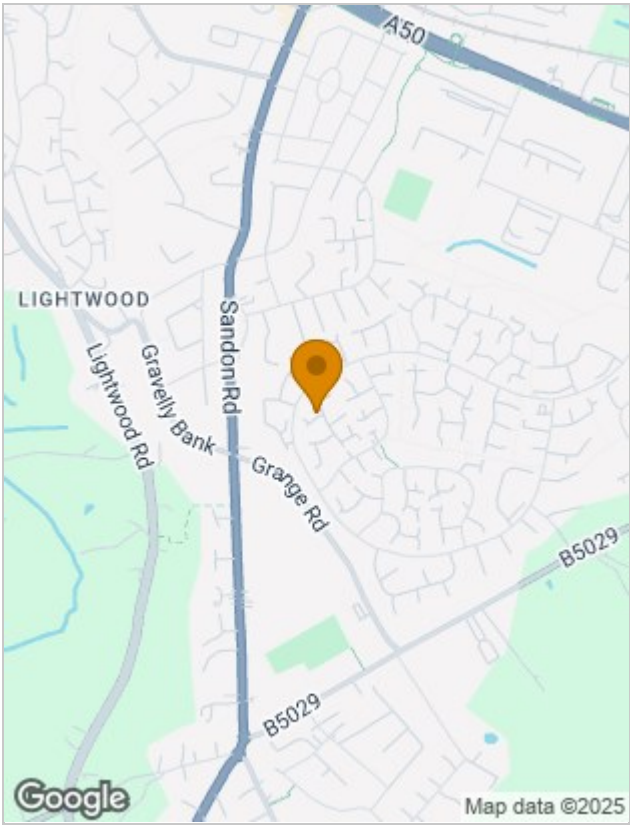

Location Map

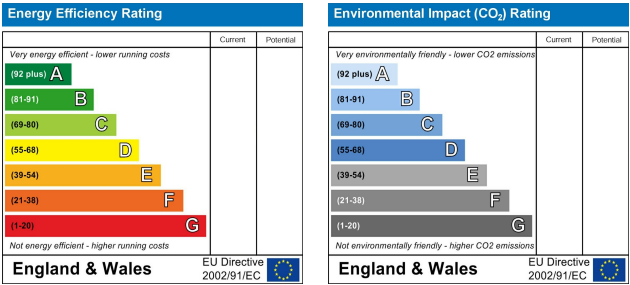
