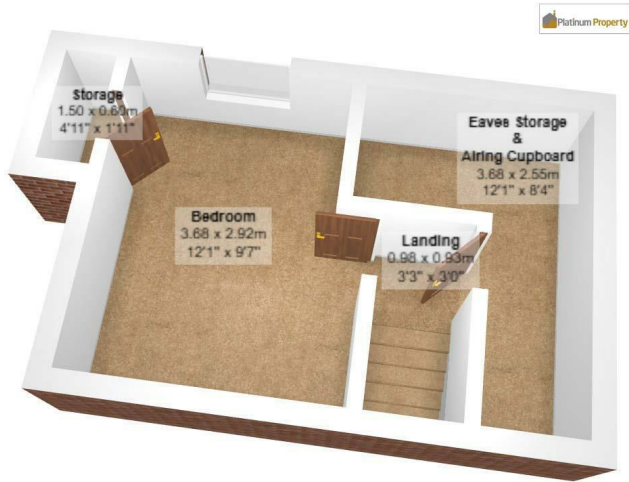

Location Map



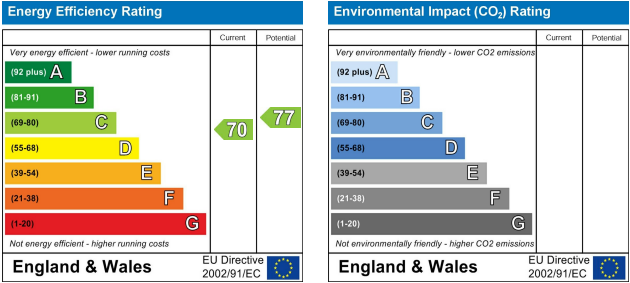
