

BLOCK PLAN (BASED ON ORDNANCE SURVEY) 1:500




LOCATION PLAN (BASED ON ORDNANCE SURVEY)
1:1250



Summary

Currently a pre-war and traditional Branksome Park House it has the benefit of two previous planning permissions. A contemporary "super home" was approved in 2011 - reference APP/11/00723/F. We understand that this planning permission is extant ie remains implementable but planning was also granted on appeal in 2009 for a large and imposing Georgian style house - reference APP/Q1255/A/08/2075033.

The site is thought to extend to approximately 1.2 acres and it is in a wonderful location on Western Road backing onto Branksome Park Woods where there is a meandering woodland walk and stream leading to the beach at Branksome Chine. There are very few houses in Branksome Park that benefit from such close proximity to the beach and even fewer which might be suitable for redevelopment. Both previously approved plans were by one of the area's leading architects, namely Anders Roberts Cheer.
