The ground floor opens with a welcoming entrance hall leading into a choice of versatile reception rooms. To the front, a family room and a study/home office enjoy views across the driveway, making them ideal for work and play. The main living room is a bright and inviting space, with a double aspect and direct connection to the garden room — a tranquil spot for reading, relaxing, or entertaining, with French doors opening onto the terrace and gardens. The kitchen is well planned with a range of wall and base units, and its wide windows capture views of the beautifully landscaped rear garden. From here, a spacious dining room creates the perfect setting for family gatherings and dinner parties. A separate utility room provides additional storage and laundry space, with side access and an internal door to the garage.











Upstairs, the generous landing leads to four comfortable double bedrooms. The principal suite benefits from fitted wardrobes and a private En suite bathroom, while the remaining bedrooms are served by a well-appointed family bathroom.
