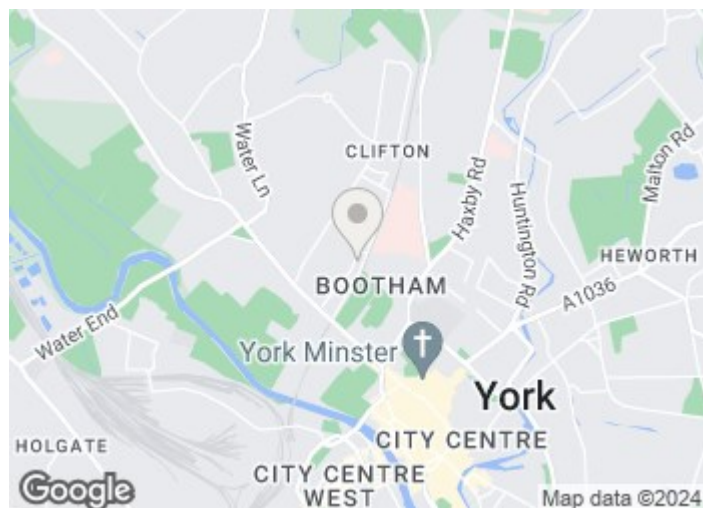

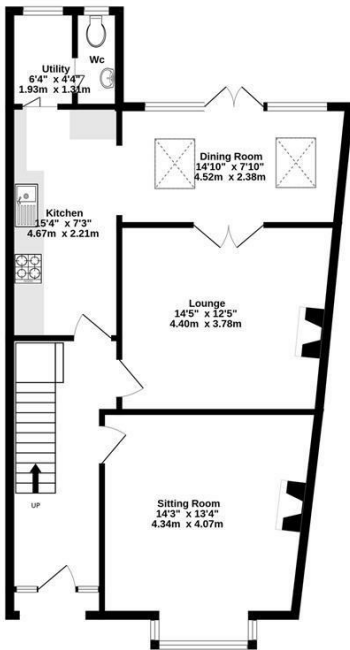

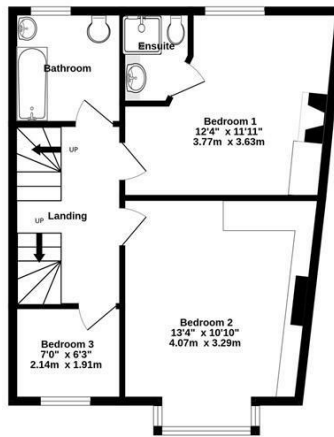


Floor Plan

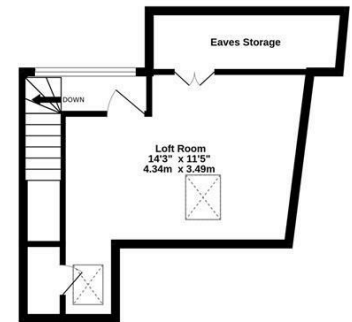
