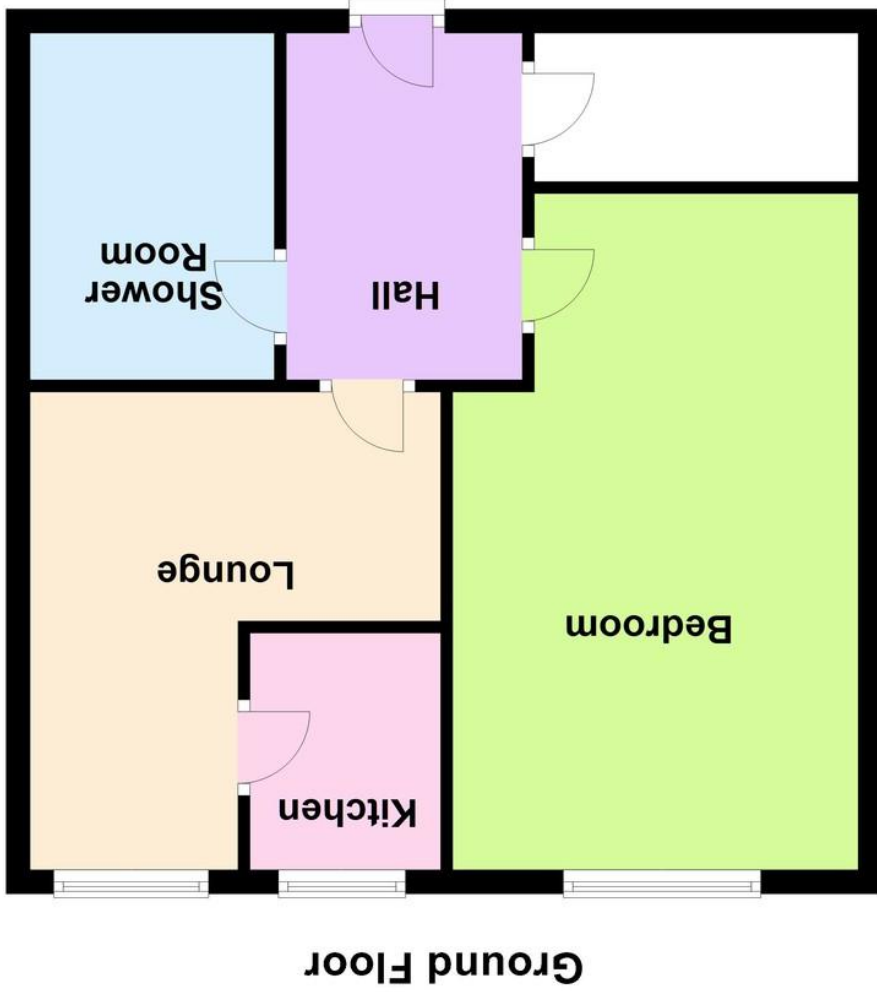
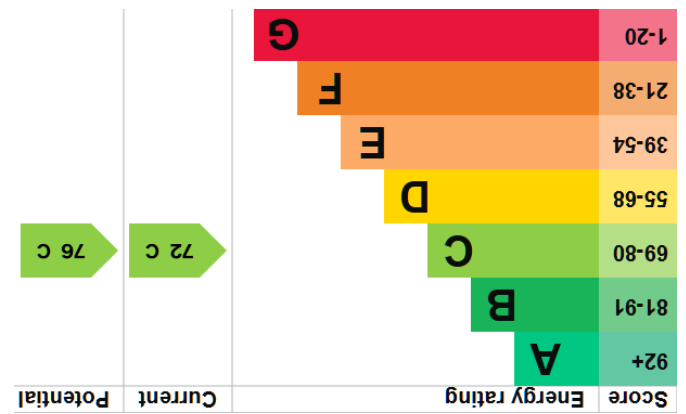


NOT TO SCALE: THIS IS AN APPROXIMATE GUIDE TO THE RELATIONSHIP BETWEEN ROOMS

This first floor retirement apartment is ideally located as it is within walking distance of Mere Green centre which offers shopping, bars, restaurants, gyms, coffee shops, doctors surgeries, library, Post Office and supermarkets as well excellent transport links via road, bus services and cross city rail services into Birmingham New Street and beyond. Regular social activities are organised by the Estate Manager and residents and there are the services of a visiting House Manager and a 24 hour Careline alarm service. The second floor apartment boasts a lounge/dining area, a bright fitted kitchen, a shower room and the bedroom has a range of fitted wardrobes. The complex also offers a communal laundry, an attractive communal lounge and communal gardens. This complex has 15 flats built in 2005 and with new residents accepted from 60 years of age, an early viewing of this apartment is strongly recommended to fully appreciate the location and accommodation on offer.

TENURE

The Agent understands that the property is leasehold with approximately 105 years remaining. Service Charge is currently running at £4136 per annum and is to be reviewed annually. The Ground Rent is currently running at £359 per annum and is to be reviewed 2029.
