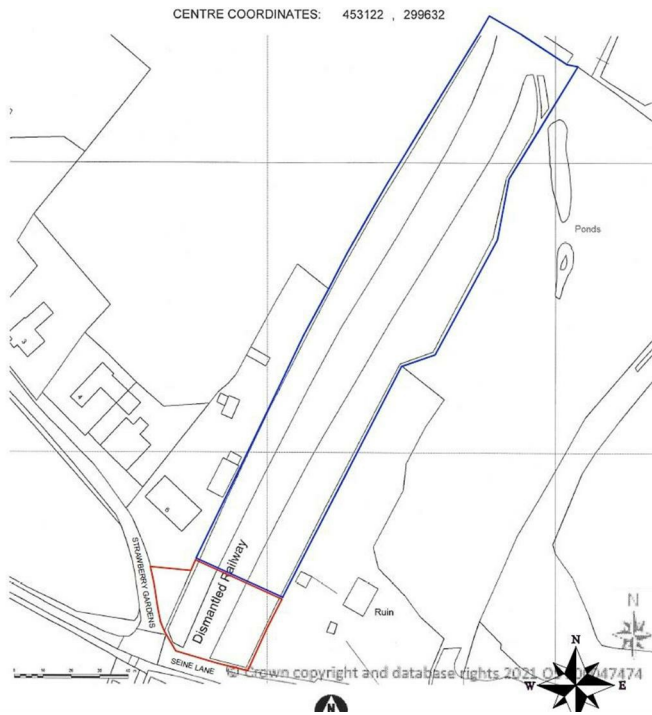

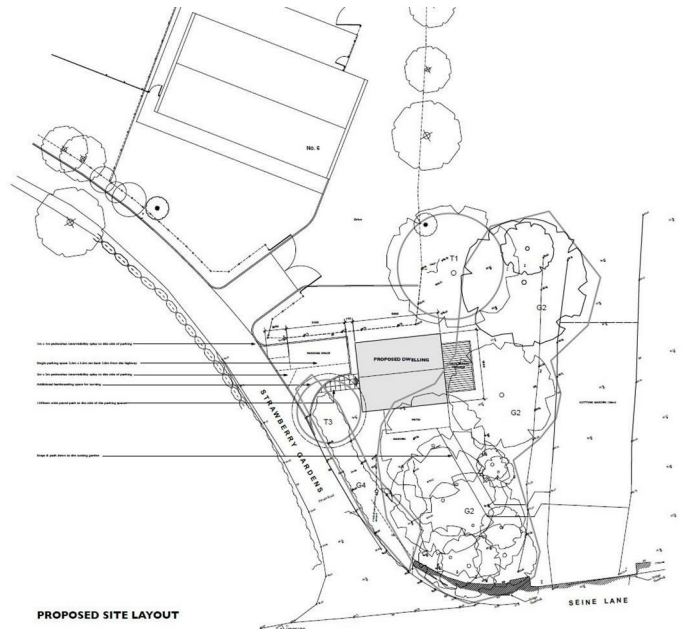

Site Plan

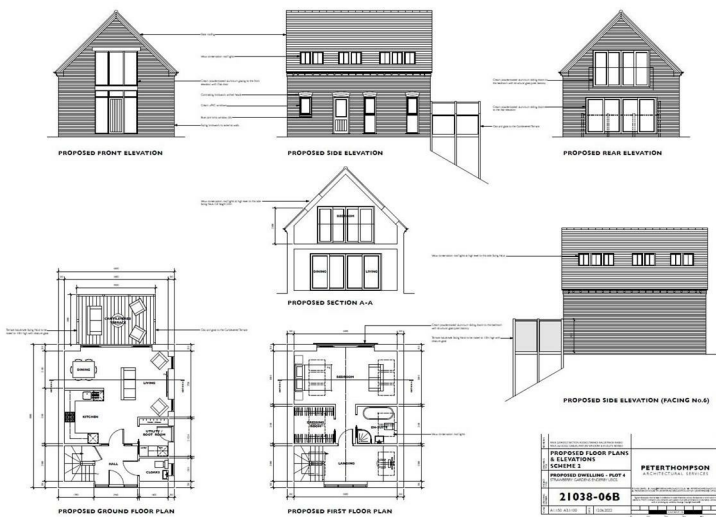

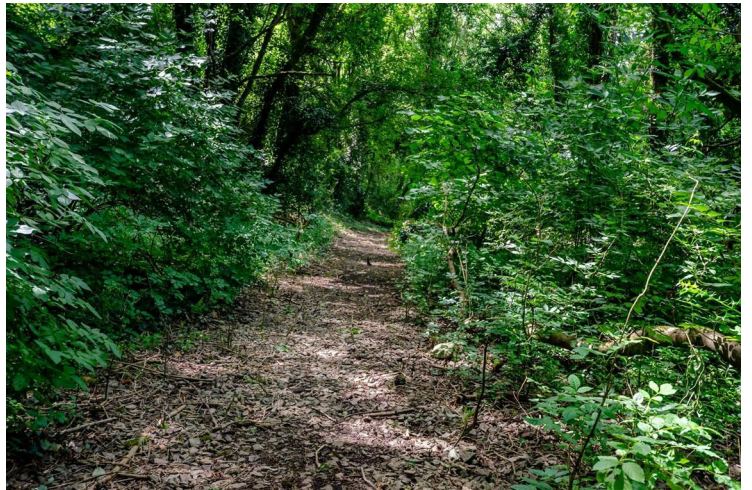

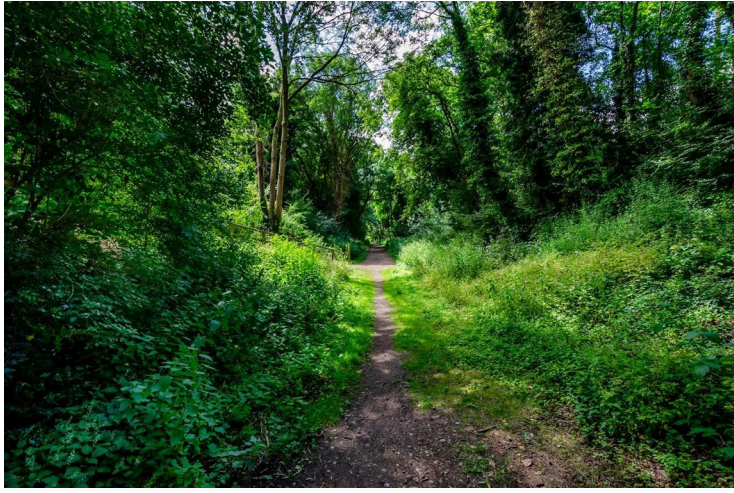
