

Location:

The location will appeal to farmers, those with equestrian interests or simply to someone who relishes the idea of owning a piece of pretty Derbyshire countryside.

Directions:

Driving from Ashbourne take the A517 and the property will be found on the left hand side just before you reach the village of Turnditch. There is a grass verge literally just before the Turnditch village sign.



Description:

The land extends to 12.5 acres (5.05 ha) or thereabouts, is laid to grassland and divided into various enclosures.

The entrance field is about two thirds of an acre and planted as an orchard with nut and fruit trees and some Willow. This small field leads to a piece of interesting woodland extending to about another two thirds of an acre and contains established Oak, Beech, Alder and a variety of other deciduous trees.

A small stream fed by a spring runs through the woodland.

To the left of the woodland is a three acre field sheep fenced and a further 8 acre field lies to the right

The land is sold freehold with vacant possession upon completion.

No mains services are connected to the land.
