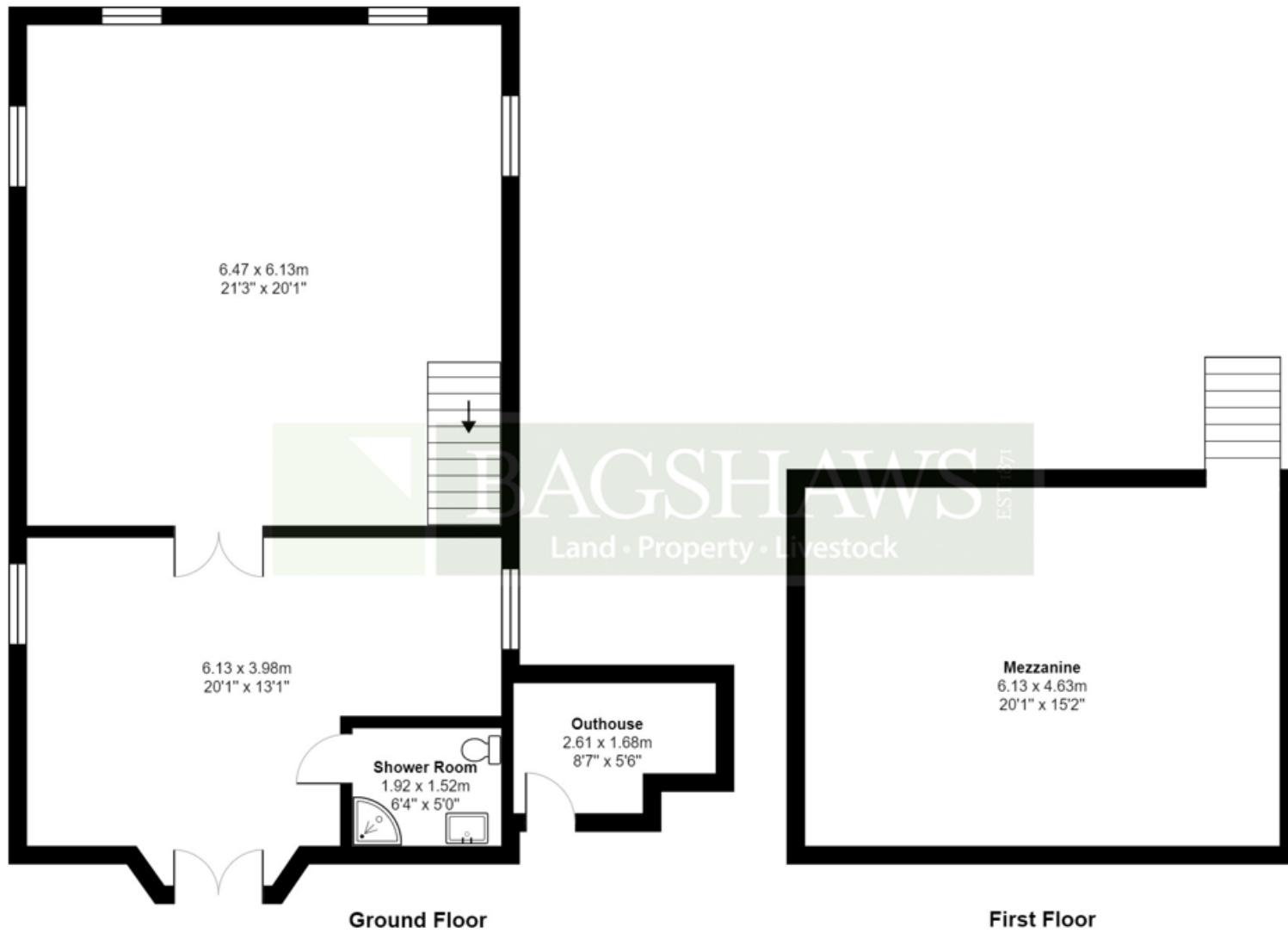
Additionally, a small stone store adjoins The Old Chapel to the east, in addition to a manageable garden and parking area for up to one vehicle.

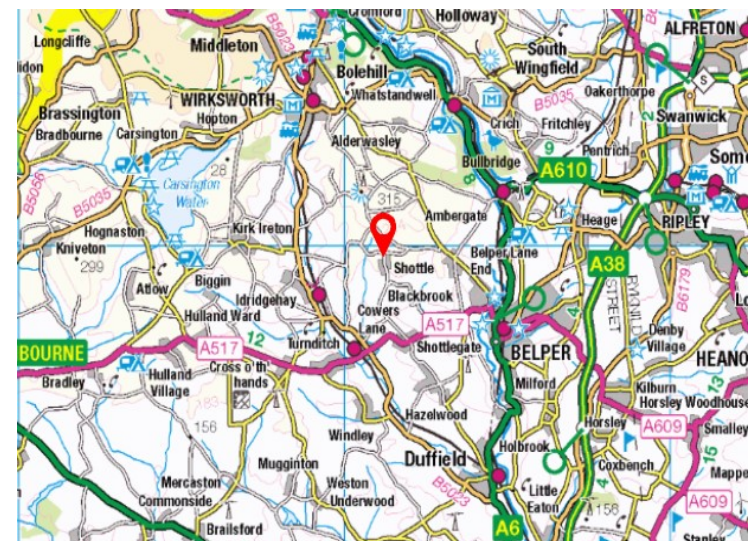
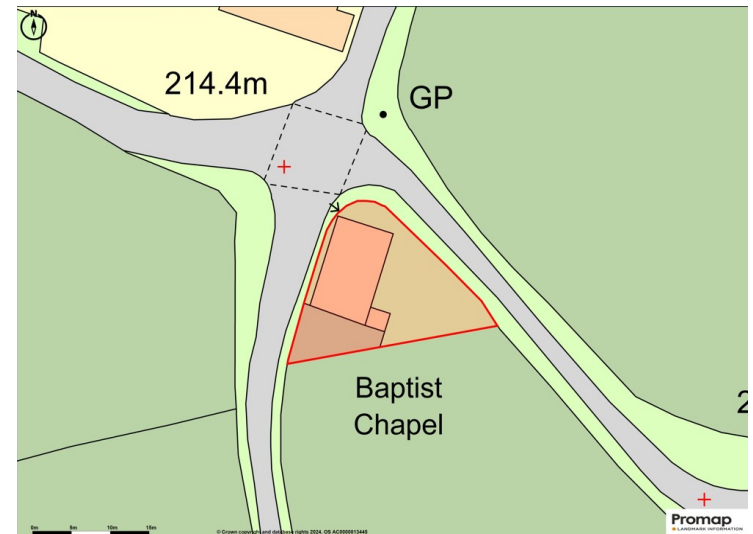
