A two bedroom second floor apartment situated in this extremely convenient and popular location just north of the A259 main road. Close to Downs Leisure Centre, a parade of shops and bus routes. Seaford town centre is approximately one mile distant, whilst local primary and secondary schools are within approximately half a mile.

A well appointed open plan kitchen has the benefit of integrated AEG fridge, freezer and dish washer as well as a four ring gas hob and double oven. The southerly aspect living space leads onto the balcony which enjoys views over green space to the park.

The property further benefits from two double bedrooms, bathroom, EN-suite shower room and an entrance hall with laundry cupboard. There is also an allocated parking bay and benefits from a 10 year NHBC warranty.

The lease is 999 years, with maintenance estimated to be £1,612 per year and ground rent is peppercorn.

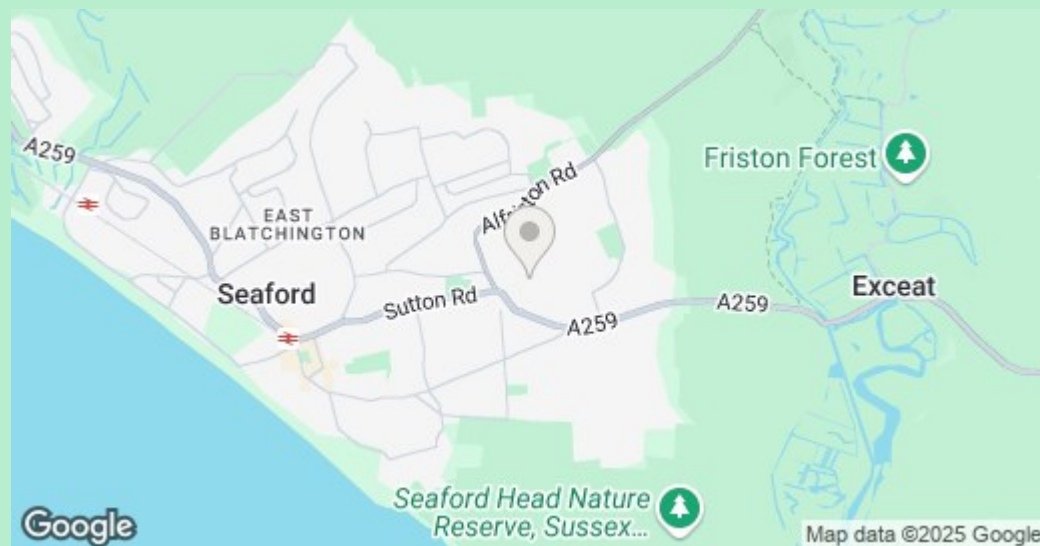
