### DESCRIPTION

### LOCATION

Saltburn-by-the-Sea is a seaside town in the borough of Redcar and Cleveland. It is situated around 11 miles east of Middlesbrough town centre, 4 miles south east of Redcar and 15 miles north west of Whitby. The town is a popular tourist attraction, with a population of 5,874 in 2021 and over 2 million visitors a year.

The property is located centrally within Saltburn, immediately to the north of the town's train station. The sea front is approximately 300 metres to the north.

This is a mixed us located with a range of commercial and leisure used forming the town centre, and a mix of residential and hotel uses to the north.

### **PLANNING**

We understand the property is Grade II Listed, and is within a Conservation Area.

The existing use falls into Class F1 (Learning and Non-Residential Institution). A pre-application enquiry confirmed that the planning authority is supportive of a change to uses within Class E (Commerical, Business and Services) and Class C3 (Residential).


