The parcel of land is located adjacent to/within the River Roach.

Of particular note, it is thought that part of the site may be the final resting place of HMS Beagle, being the famous ship used by Charles Darwin while he was contemplating his evolutionary theories. The land includes part of the Scheduled Monument known as Mud Berth for CGWV No 7 (formerly HMS Beagle) (List Entry Number: 1467785).

The land is part of the Crouch and Roach Estuary SSSI, as well as being within the Crouch & Roach Estuaries (Mid-Essex Coast Phase 3) RAMSAR site and Special Protection Area. It is also in a Special Area of Conservation (SACs).

The land is situated within the Greenbelt.
