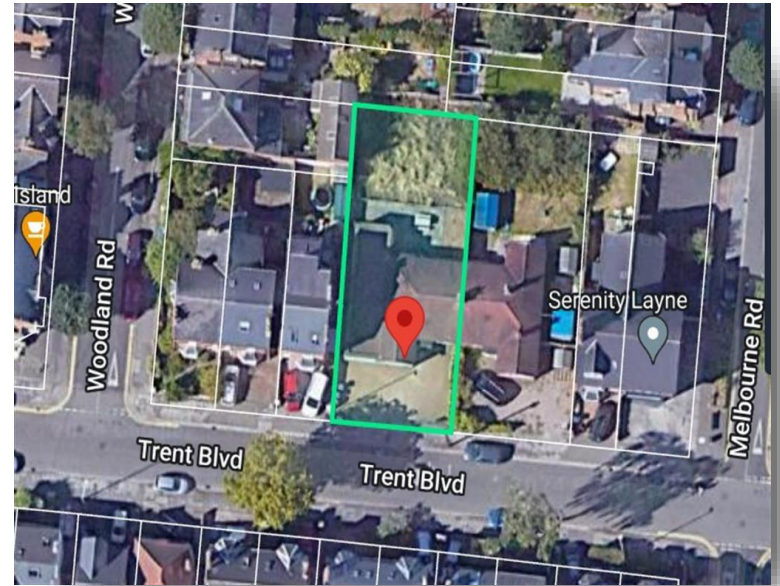
### **Planning Permission**
