Decription

A delightful Grade II listed Georgian townhouse located within the city walls of Chester, which would benefit from some updating. The property has three bedrooms, reception room, kitchen, downstairs WC, useful cellar room and shower room. To the rear of the house there is a small courtyard garden.

Entrance Porch

Sitting Room

Living flame gas fire with ornate surround and tiled hearth. Window with secondary glazing to front. Open staircase to first floor. Exposed timber flooring. Coved ceiling. Radiator.

Inner Hall

Fitted cupboard.

Downstairs Cloakroom

Low level WC and hand wash basin with mixer tap.

Kitchen

Range of wall and base units with marble effect work surface above and stainless steel sink unit with mixer tap. Floor to near ceiling cupboard housing gas fired boiler. Space for electric cooker. Space for washing machine, dishwasher and fridge. Window and glazed door to rear. Tiled floor.

Cellar Room

Useful room with power and light.











First Floor Landing Access to loft.

Bedroom One Window to rear. Radiator.

Bedroom Two Window with secondary glazing to front. Radiator.

Bedroom Three Window secondary glazing to rear. Radiator.

Shower Room

Walk in shower, low level WC and hand wash basin with mixer tap and vanity unit below. Tiled walls. Wall mounted heated towel rail. Tiled floor.

Outside

There is a small courtyard garden with side access.
