Holding Deposit

*Please be aware that all of the above is also relevant to any guarantor applications that may support your tenancy.

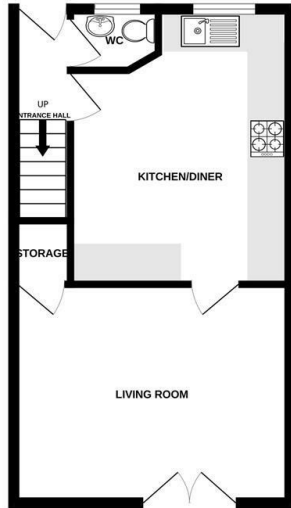
Deposit (Bond)

The deposit (bond) amount is equivalent to 5 weeks' rent.

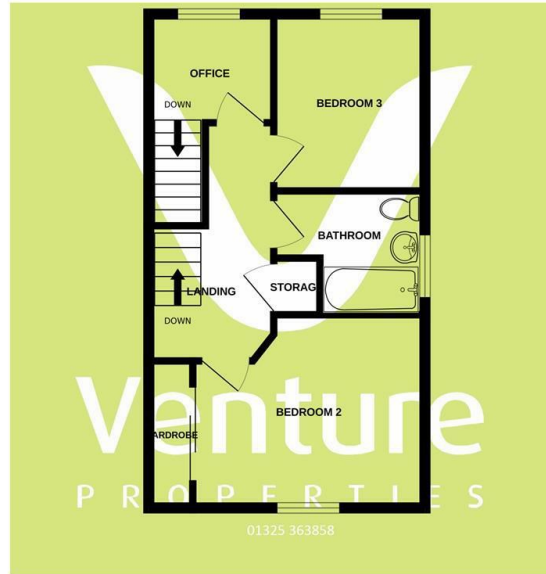

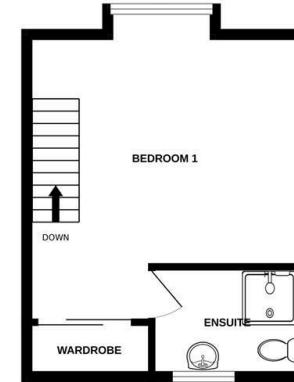
GROUND FLOOR



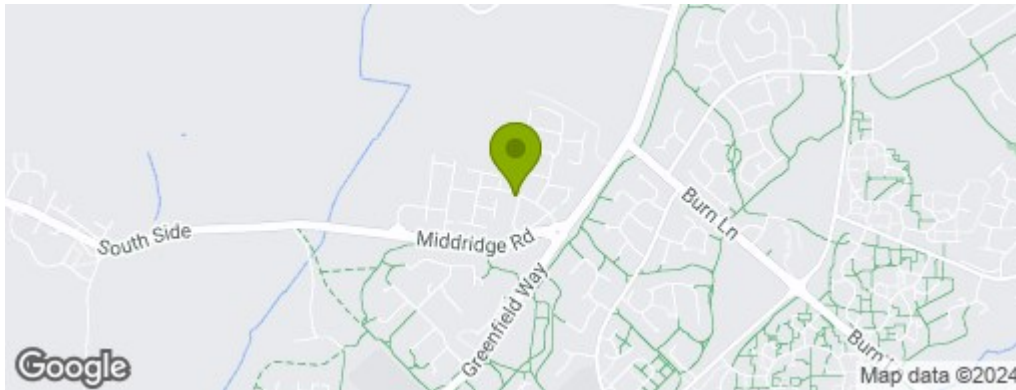
1ST FLOOR
