Holding Deposit

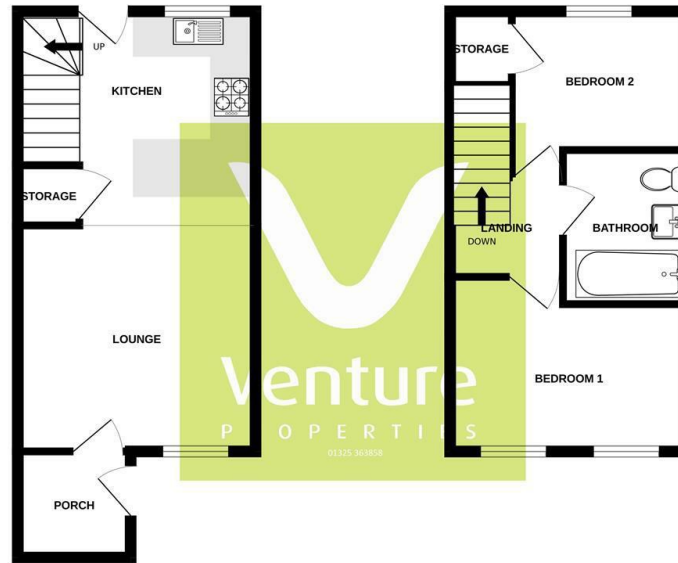
The deposit (bond) amount is equivalent to 5 weeks' rent.

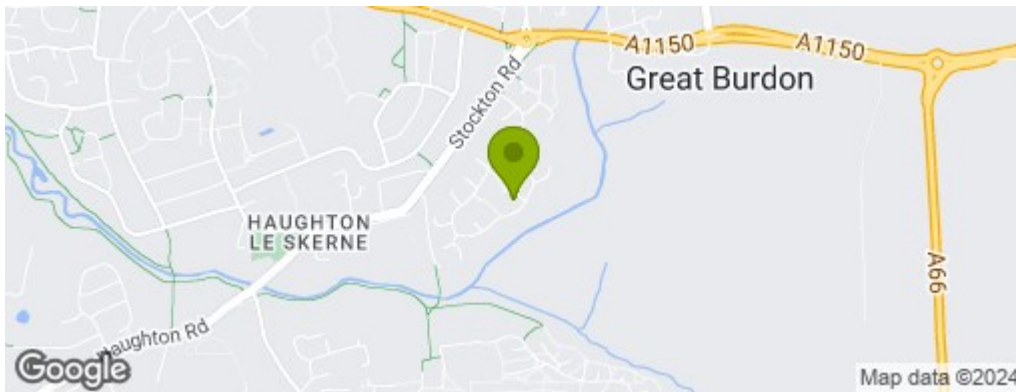
