#### **Holding Deposit**

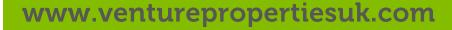


