

SUMMARY

Silver Sands Court was built by McCarthy & Stone purpose built for Retirement Living. The development consists of one and two-bedroom retirement apartments for the over 60s. There is a House Manager on site and a 24-hour emergency call system provided via a personal pendant alarm and with call points in the bathroom.

The apartment features a fully fitted kitchen, one bedroom, lounge and shower room. The existing furnishing are open to negotiations. The development includes a Homeowners' lounge and beautiful landscaped gardens. There is a guest suite for visitors who wish to stay (additional charges apply). A car parking permit scheme applies, check with the House Manager for availability.

Silver Sands Court is in Bembridge situated at the most easterly point of the Isle of Wight Bembridge is thought to be the largest village in England and has long been regarded as a popular tourist destination. The village has three beaches, a harbour, RSPB nature reserve, Lifeboat station and its own airport. The village centre hosts a number of independent shops, cafe and restaurants, together with some well known high street retailers. There is a post office located in the Lane End Road supermarket store.

It is a condition of purchase that all residents must meet the age requirements of 60 years.





ENTRANCE HALL

Front door with spy hole leads to the large entrance hall - the 24-hour Tunstall emergency response pull cord system is situated in the hall. From the hallway there is a door to a walkin storage cupboard/airing cupboard. Illuminated light switches, smoke detector, apartment security door entry system with intercom and emergency pull cord located in the hall. Doors lead to the bedrooms, living room and bathroom.

LOUNGE WITH BALCONY

With a glazed door and window leading out to the private balcony with scenic outlook. TV and telephone points. Two ceiling lights. Fitted carpets, raised electric power sockets. Partially double glazed doors lead onto a separate kitchen.

KITCHEN

Fully fitted kitchen with tiled floor. Stainless steel sink with mono block lever tap. Built-in oven with retractable door, ceramic hob with extractor hood and fitted integrated fridge, freezer, slimline dishwasher and under pelmet lighting.

BEDROOM

Benefiting from a walk-in wardrobe. Ceiling lights, TV and phone point.

SHOWER ROOM

Fully tiled and fitted with suite comprising of walk-in shower, WC, vanity unit with sink and mirror above.
