LOCAL AREA

ENTRANCE HALL

Front door with spy hole leads to the large entrance hall - the

24-hour Tunstall emergency response pull cord system is situated in the hall. From the hallway there is a door to a walk-in storage cupboard/airing cupboard. Illuminated light switches, smoke detector, apartment security door entry system with intercom and emergency pull cord located in the hall. Doors lead to the lounge, bedroom and bathroom.

LOUNGE

Spacious lounge with ample room for dining has the benefit of a Juliet balcony overlooking communal grounds. There is a feature electric fire with surround which acts as an attractive focal point. There are raised electric sockets, TV and telephone points. Partially glazed door leads onto a separate kitchen.

KITCHEN

Well equipped modern kitchen with tiled floor and a range of low and eye level units and drawers with a roll top work surface. Stainless steel sink with mono lever tap, drainer and electrically operated kitchen window above. Eye level oven, ceramic hob, cooker hood and integral fridge / freezer.

BEDROOM

Double bedroom benefiting from a mirror fronted built in wardrobe. Raised electric sockets, TV and telephone points.

BATHROOM

Fully tiled and fitted with suite comprising of level access wet room style shower and bath both with hand rails. Low level WC, vanity unit with wash basin and mirror above. Electric shaving point, heated chrome towel rail and extractor fan. Slip resistant flooring.
