Description

Unit 2 is a mid-terrace industrial warehouse situated in a modern trade park within an established commercial area. This modern unit has gas and three-phase electricity and externally there is good loading access through a full height roller shutter door with allocated parking to the front.

Brentwood Trade Park is situated within the established commercial area of Tallon Road, Brentwood. The estate is approximately 1.5 miles from the A12 and 4.5 miles from the M25 (J28); with the M11 /M25 junction being approximately 10 miles to the west, the A13/Dartford Crossing junction is approximately 15 miles eastwards. Northwards along the A12 the major Ports of Harwich and Felixstowe are within approximately 55 miles.

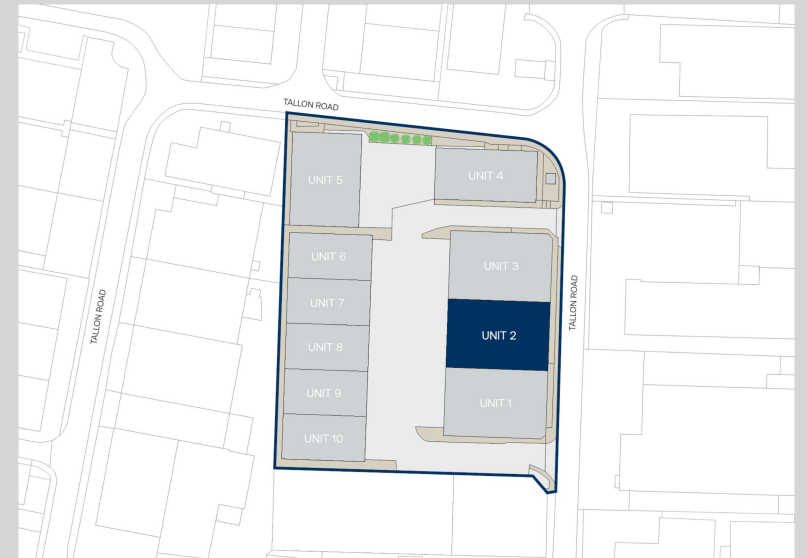
