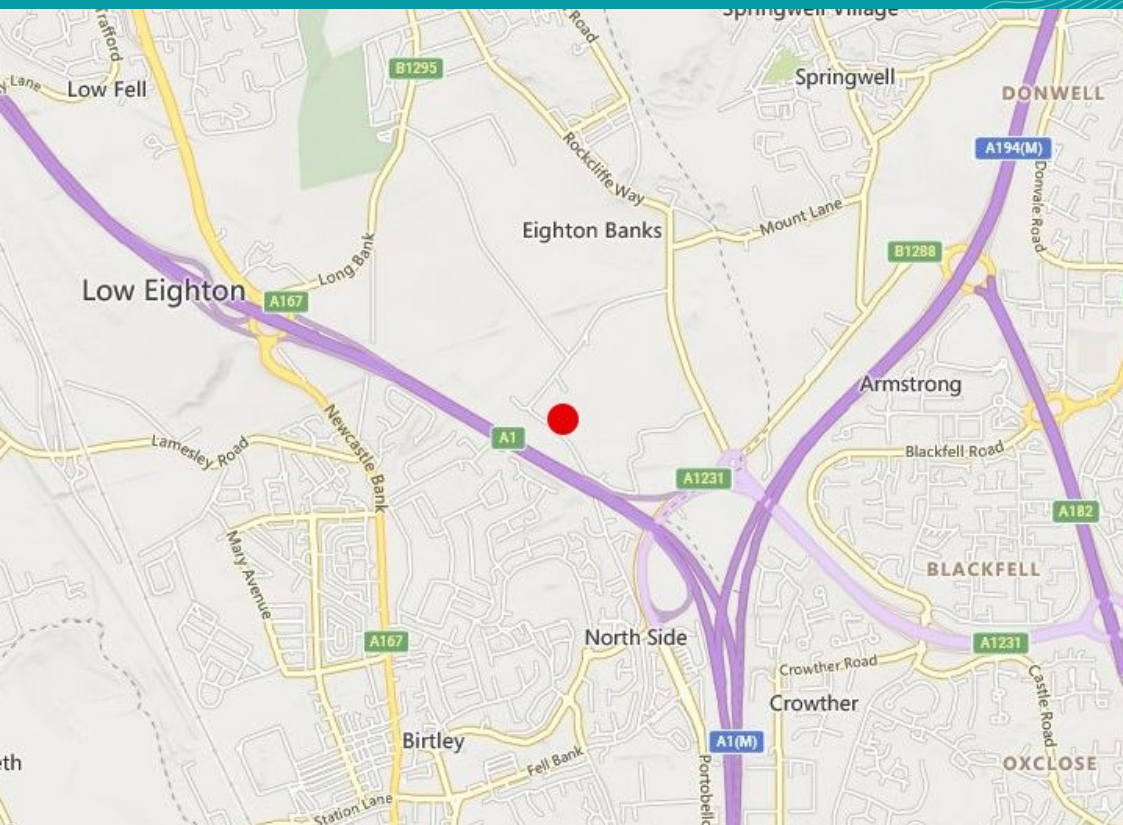

DESCRIPTION

Blackfell Hauler House is a scheduled ancient monument built in 1915 as part of the Bowes Railway. A brick building under dual pitched slate roof with a solid concrete floor housing the original machinery over a basement. Externally there is an area suitable for parking and the remainder of the site is scrubland offering scope for alternative uses such as light industrial, art studio, storage, tourism, live/work. We understand that mains water is connected but there is no electricity or gas. Further service details on application.
