


Indicative full floor space plan



Fourth floor




Third floor (part)

Indicative layout








The town is the focal point for economic growth along the M4 motorway and is classed as one of the most vibrant urban centres in the UK.


Berkshire has a highly skilled and affluent catchment area which boasts excellent leisure and educational facilities as well as access to the beautiful surrounding countryside.




















CONNECTIONS

Reading's strategic location, in the heart of the UK's transport network and its proximity to Heathrow and London, is one of its major attractions.





Reading railway station is one of the busiest rail hubs in Britain, connecting to London (Paddington and Waterloo) to the east, Birmingham to the north and Cardiff to the west.

Trains to London Paddington run every 10 minutes with a quickest journey time of 26 minutes.

The Elizabeth Line offers direct connections to the West End, the City and Canary Wharf.
