


Located on the edge of Twyford Village in a highly accessible location, a short drive to the A4 between Maidenhead and Reading.

The M4 Motorway is easily reached via Junction 8/9 or the A329m link to Junction 10.


The mainline station (Elizabeth Line) and centre amenities are a short walk away.
