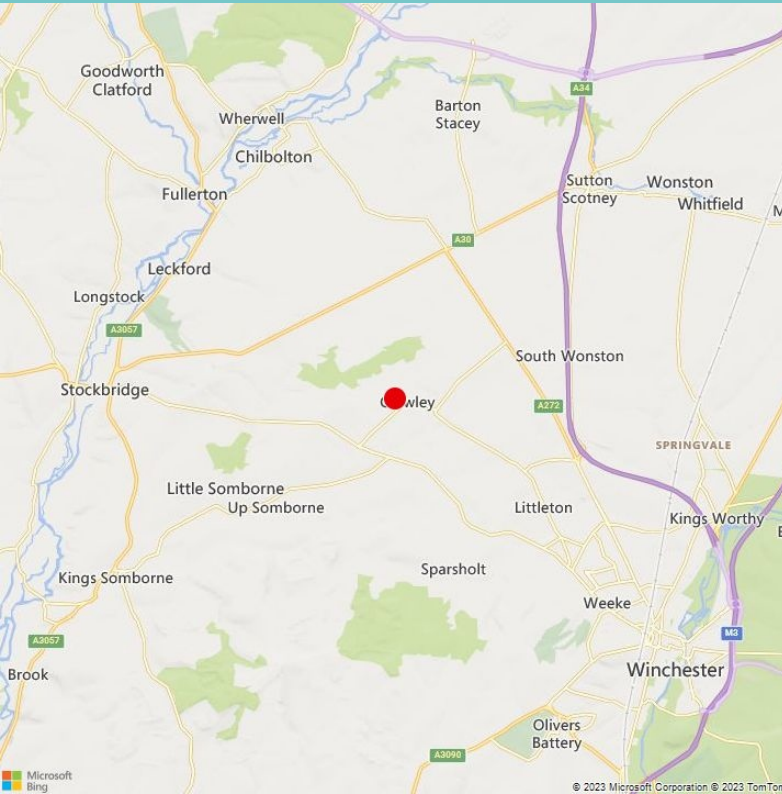


LOCATION
