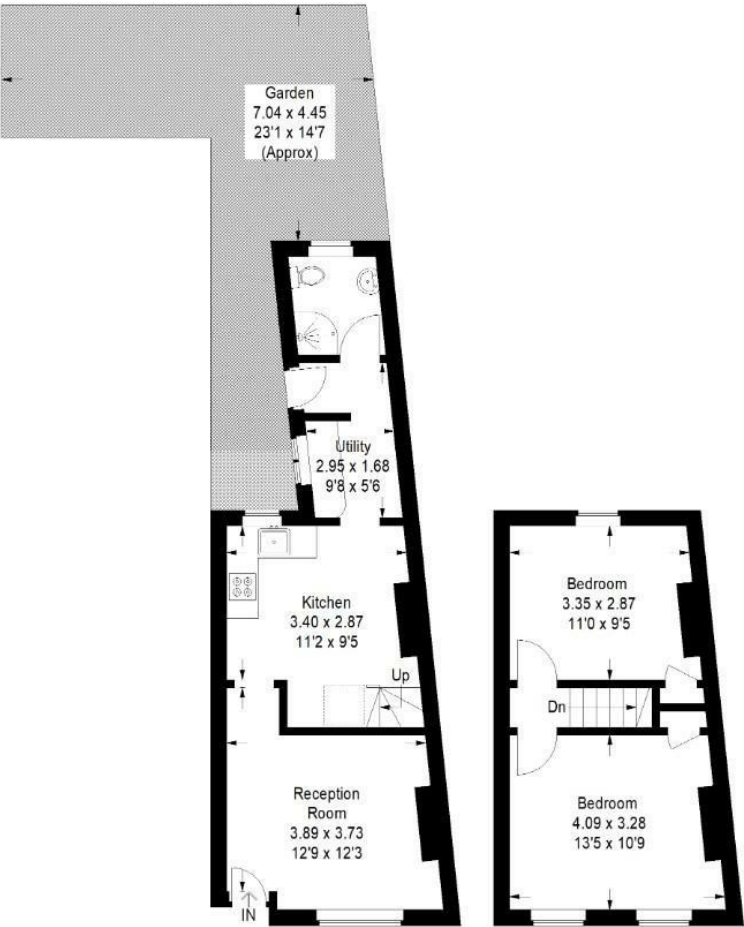
Floorplan

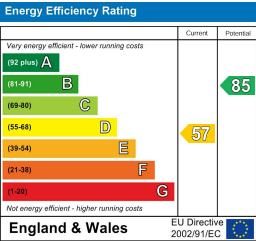
