In Detail

A four bedroom mid-century townhouse forming part of a popular quiet cul-de-sac next to Westow Park.

The accommodation is arranged over three floors and has been remodelled to include an additional shower room / therapy room on the ground floor. The dual aspect reception room is flooded with natural light through large windows and includes stripped wood flooring, whilst being socially open to a dining area next to the kitchen. The kitchen has been recently upgraded with plenty of storage and Neff appliances, whilst the top floor houses three bedrooms and the main bathroom. There is a generous, boarded, attic space which lends potential for extension (STP) if desired.

Externally the rear garden is a blank canvas for the green-fingered, whilst there is also the benefit of a garage and off street parking to the front.

Wakefield Gardens is a small, community-orientated street which works well for a wealth of shopping and leisure options at the Triangle in the centre of town. Also proximity to popular primary schools such as Paxton and Cypress, and use of a large separate communal garden.

An ideal option for a young or growing family seeking a long term new home.

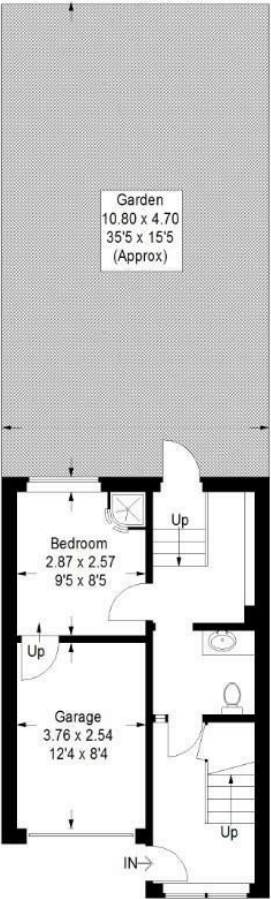

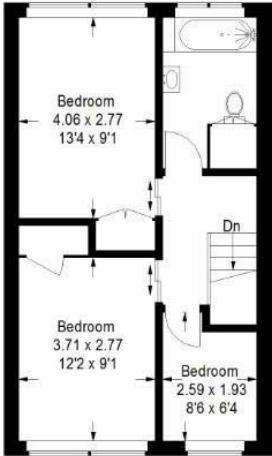
Floorplan

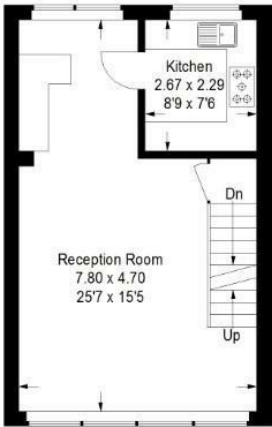

Ground Floor

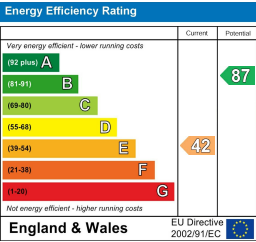


Second Floor
