Set back from the road along a small service road, this nicely presented and maintained traditional detached bungalow enjoys a lovely established rear garden backing directly onto the pleasant Fibbersley Nature Reserve. The accommodation includes a porch, welcoming L shaped reception/inner hall, a spacious rear lounge/dining room with French doors opening onto a timber decked patio, and a fitted kitchen with oven and hob. There are two bedrooms, one featuring a range of fitted wardrobes, a modern re-fitted shower room and a side hallway with useful storage rooms and a separate WC. Outside, the property sits behind a neat lawned front garden with a block-paved driveway offering ample off-road parking. Further benefits include gas central heating with a Worcester combination boiler, UPVC double glazed windows, and a great location just 1.5 miles from Bentley Bridge Shopping Centre and around 3 miles from Wolverhampton city centre.
