A well maintained semi-detached family home offered for sale by way of The Modern Method of Auction. This delightful three bedroom property benefits from no upward chain and cash buyers are preferred.

The property provides spacious accommodation offering two good size reception rooms, a fitted kitchen area with lobby and a useful downstairs WC off, a modern first floor shower room and three generous bedrooms. The property is centrally heated and double glazed (where specified).

There is a paved area to the front ideal for off road parking and an extensive rear garden private from neighbouring properties with patio areas and lawn area. Council Tax Band A. Energy Rating C. Tenure FREEHOLD.

Auctioneer Comments. This property is for sale by the Modern Method of Auction. Should you view, offer or bid on the property, your information will be shared with the Auctioneer, Iamsold Limited. The Reservation Fee is paid in addition to purchase price and will be considered as part of the chargeable consideration for the property in the calculation for stamp duty liability. Buyers will be required to go through an identification verification process with Iamsold and provide proof of how the purchase would be funded. This property has a Buyer Information Pack which is a collection of documents in relation to the property. The documents may not tell you everything you need to know about the property, so you are required to complete your own due diligence before bidding. A sample copy of the Reservation Agreement and terms and conditions are also contained within this pack. The buyer will also make payment of £300 including VAT towards the preparation cost of the pack, where it has been provided by Iamsold. Dining Room 14' 3" x 11' 6" (4.34m x 3.50m) Having pebble effect electric fire, central heating radiator and double glazed window.

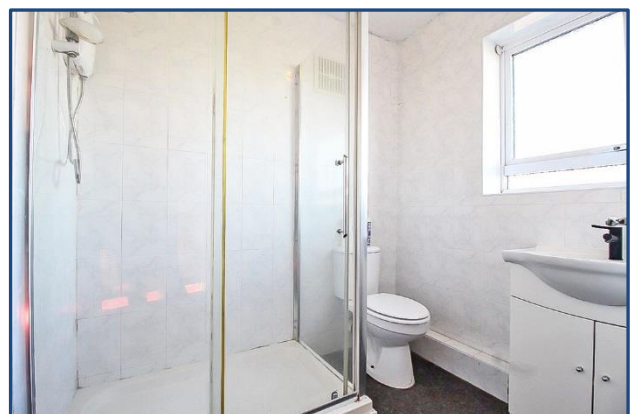

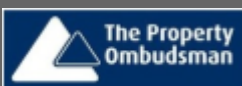
