At the heart of Cockermouth's bustling Market Place you will find these prominent shop premises that have been let successfully for a number of years. Cockermouth is renowned for its independent retailers and gem town status attracting residents from throughout the region and holiday makers alike. Market Place has developed into one of the most attractive areas of the town.

A separate entrance off Castlegate leads to a beautiful two bedroom maisonette with spacious accommodation spread over two floors and boasting an abundance of period features including exposed timber beams and natural stone, a curved staircase, sliding sash windows and open fireplaces. Both areas of the building are now let out bringing in a regular income close to £12,000 per annum.

Cockermouth is the birthplace of poet William Wordsworth and the hub for many popular festivals and events making it an alternative quiet tourist destination.

### **RETAIL PREMISES**

The Ground floor retail premises are in a prominent corner location in the Market Place, with large window frontage perfect for a range of businesses. The rental income from the premises is around  $\pounds$  6,000 per annum.

The current rental income from the property amounts to approximately £12,000 per annum which represents a yield in the region of 5%. Both the retail space and maisonette are currently tenanted.

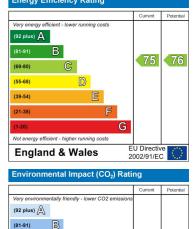
