Location

The property is located on County Court Road, just off London Road, the main arterial thoroughfare through Kings Lynn town centre. Vancouver House is within walking distance of the main pedestrianised high street, convenient for the train station and the bus station.

Heading into the town centre along London Road from the Southgates roundabout, immediately after the entrance to the Walks, turn right down County Court Road. The property is located on the left and can be identified by our To Let board.

Kings Lynn is a busy market town offering both primary and secondary schools, a range of health and leisure centres and extensive shopping facilities including both national and local retailers along with direct train routes to London Kings Cross (1hr 40 mins approx.) and is served by the A47, the main route between Birmingham and Gt Yarmouth, the A10, A17 and the A149.

Description

Vancouver House is a large 4-storey office block offering flexible extensive office space with allocated parking.

The communal areas comprise male/female toilets (currently under refurbishment), entrance halls and stairwells and the property is accessed via both sides of the building.

Many of the suites have been stripped out in readiness for Tenant's bespoke fit out.

Current occupiers include Cambridge Community Services and NHS.

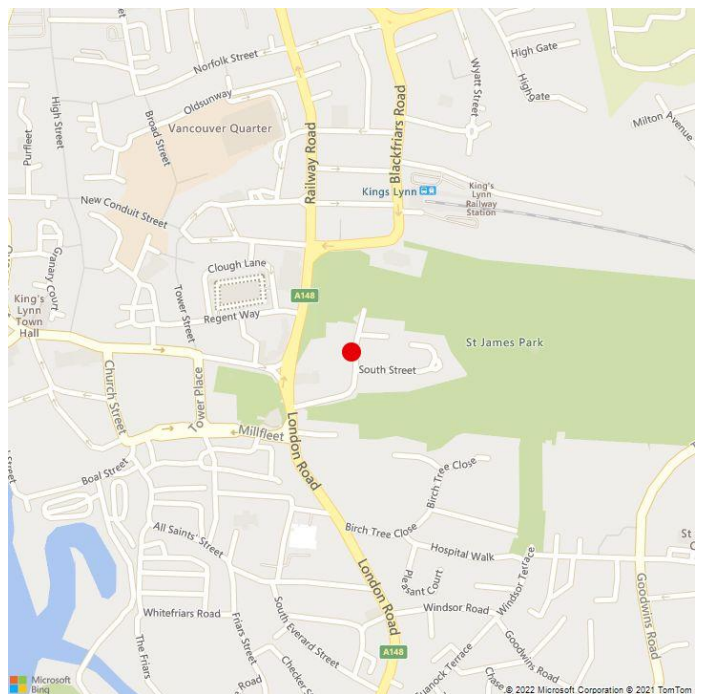
