## Location

46-48 Bridge Street is located on the northern side of Bridge Street, close to the main Hollies Car Park and Morrisons Supermarket.

Downham Market is a traditional Norfolk market town (population approx. 11,500) and serves a substantial catchment area. The town is located 10 miles south of the sub regional centre of King's Lynn, 35 miles east of Peterborough and 35 miles north of Cambridge with a mainline railway station to London Kings Cross (approx. 1 hour 20 mins).

The town provides an extensive range of amenities and facilities including a range of local and national retailers, junior and senior schooling, health services and is scheduled for further expansion.

#### Description

The property comprises an extensive purpose-built retail premises with frontage to Bridge Street, with potential for alternative uses (subject to planning), providing mainly open plan space with minimal column intrusions and good clear height to the main floor space.

The first floor flat is also available for sale subject to separate negotiation but will not be sold independently.
