The property is located at the rear of 86 Newcastle Ave in the centre of Worksop. Access is via the driveway right of way between 84 and 86 Newcastle Ave.

#### **Description**

The site extends to a total of approx. 0.51 acres and includes an open former car park area of approx. 0.3 acres. The rest of the site consists of several basic lockup industrial/storage units some with power including 3 phase.

Note: There is currently no foul drainage nor water albeit services are believed to be in the vicinity. The site partly sits within Flood Zone 3. The site is fenced and gated.
