## LOCATION

Crewe is an affluent market town situated in the District of Crewe and Nantwich and the County of Cheshire. The Market Centre is situated within the core retail area of Crewe Town Centre, fronting the junction of the prime pedestrianised retail thoroughfares of Victoria Street and Market Street.

## DESCRIPTION

The Market Centre comprises 25 retail units with ground floor retail sales accommodation and first floor ancillary. In total there is 154,130 sq ft (14,319 sq m) of retail and ancillary accommodation and over the past few years the annual footfall has ranged between approximately 3.8-4M.

The scheme can be accessed from both the town centres high street retailing pitch and also via a surface car park entrance which comprises 294 spaces.

The premises comprise of the following approximate floor areas:

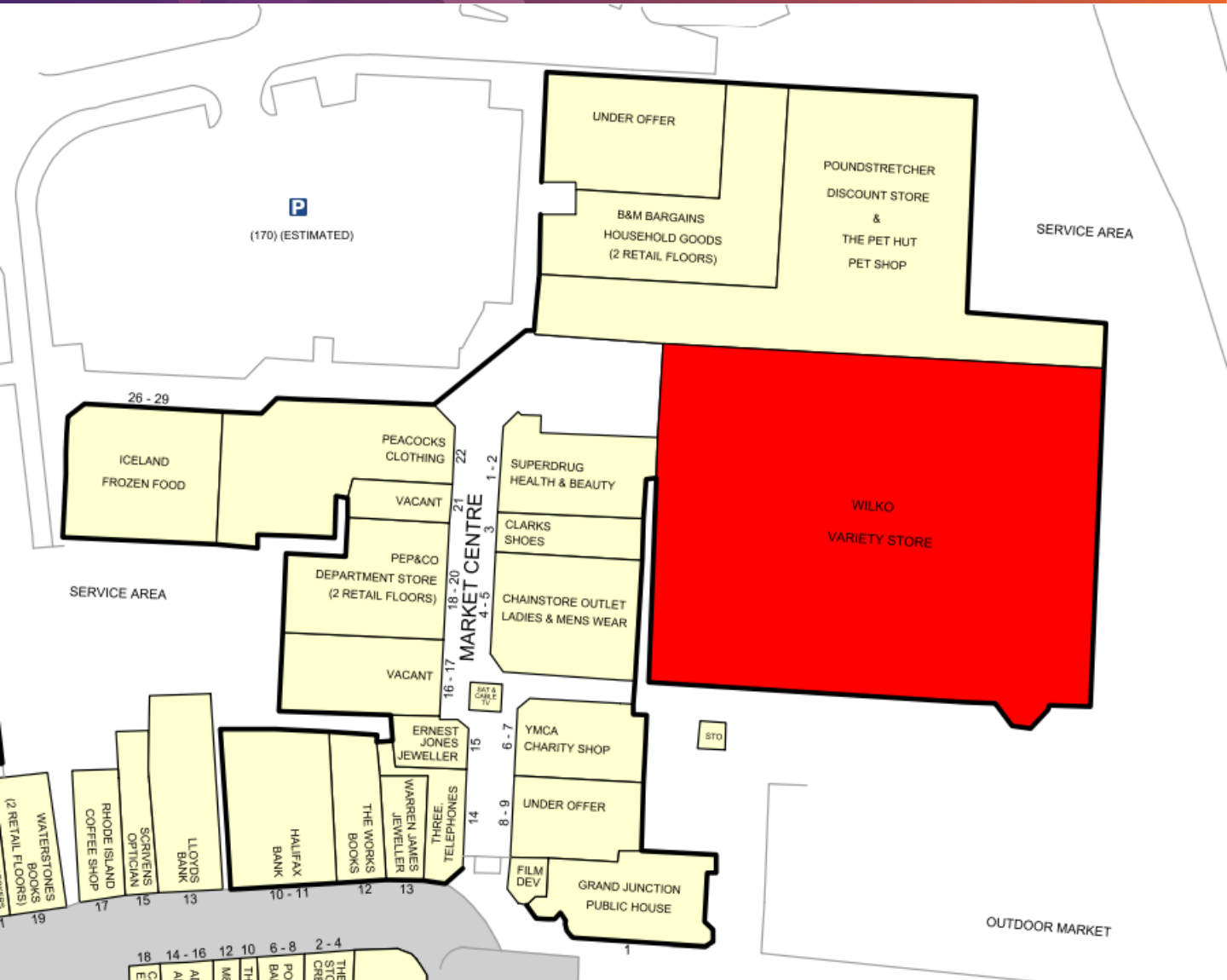
