#### The Property

270 North is situated in a prime position in the extremely sought after Pentire Peninsular area of Newguay. The apartment is arguable the best positioned in the block as its benefits from a corner position with dual aspect windows and a wrap around around balcony.

A security coded lift provides access directly to the third floor. Upon entering the apartment the entrance hall provides access to the subsequent accommodation. 




