# **LOCATION**

West Oxfordshire Business Park is located at the entrance to the town of Carterton, currently the second largest settlement in the district and the subject of major strategic housing and commercial development. The Park is directly opposite RAF Brize Norton, the hub of an expanding Transport Command, which is providing increasing business opportunities in the locality. It is less than a mile from the town centre.

Carterton is within easy reach of Witney (4 miles), Oxford (18 miles), Faringdon (10 miles), Swindon (22 miles) and Cheltenham (26 miles).

# DESCRIPTION

Currently undergoing construction, Unit 5 will offer approx. 9,084 sq.ft. G.I.F.A., comprising open-plan workshop space, plus ground & 1st floor offices. The

unit will be constructed to a high specification with reconstituted stone elevations, perimeter high level windows, large roller shutter doors and 5.5m clear eaves height. Ample car parking will be provided.
