LOCATION

With accommodation arranged over a ground & first floor the premises offer workshop, storage, production area on the ground floor, with high quality open-plan offices across the first floor. The unit benefits from 3 phase electrics, gas fired central heating to the offices, Cat 2 lighting, carpets to the

offices, intruder alarm, and an electrically operated roller shutter door. Toilet facilities are provided on both floors along with a shower and kitchen. 8 dedicated car parking are provided. To the side of the building is a gravelled area on which a 40' storage container is located.
