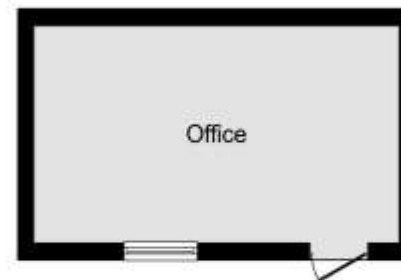




**Ground Floor**
