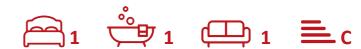

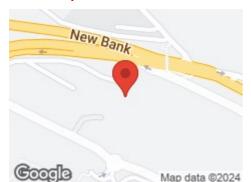








#### **Road Map**



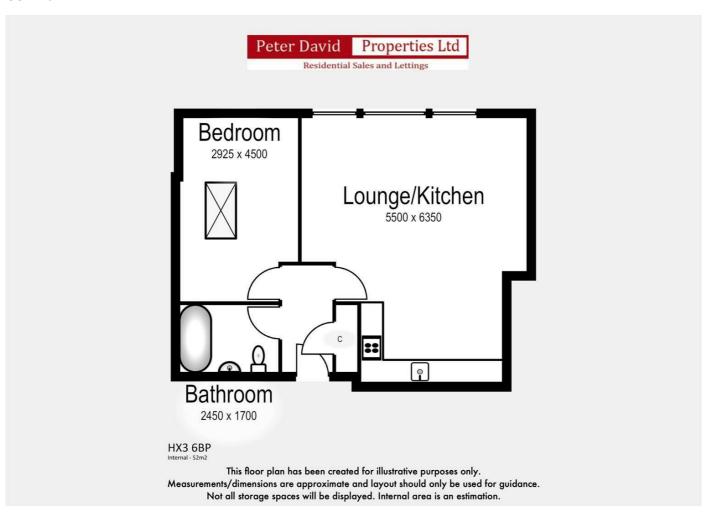
#### **Hybrid Map**



#### **Terrain Map**



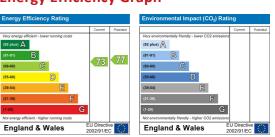
