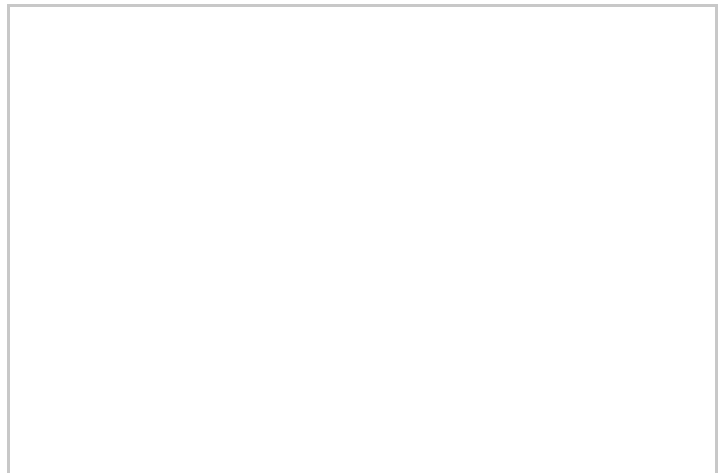
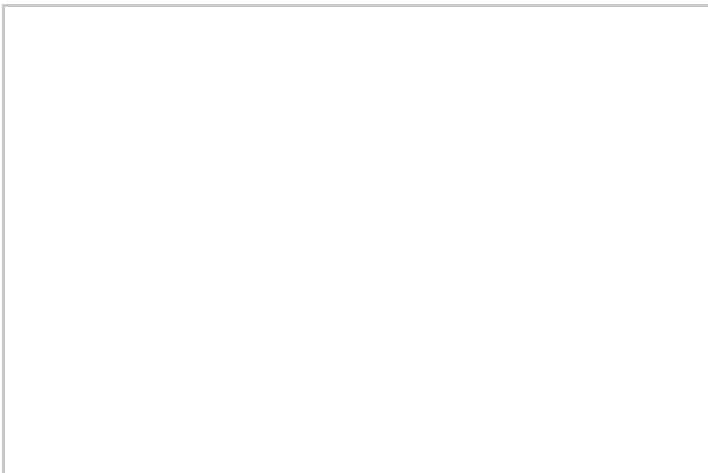

Council Tax Band

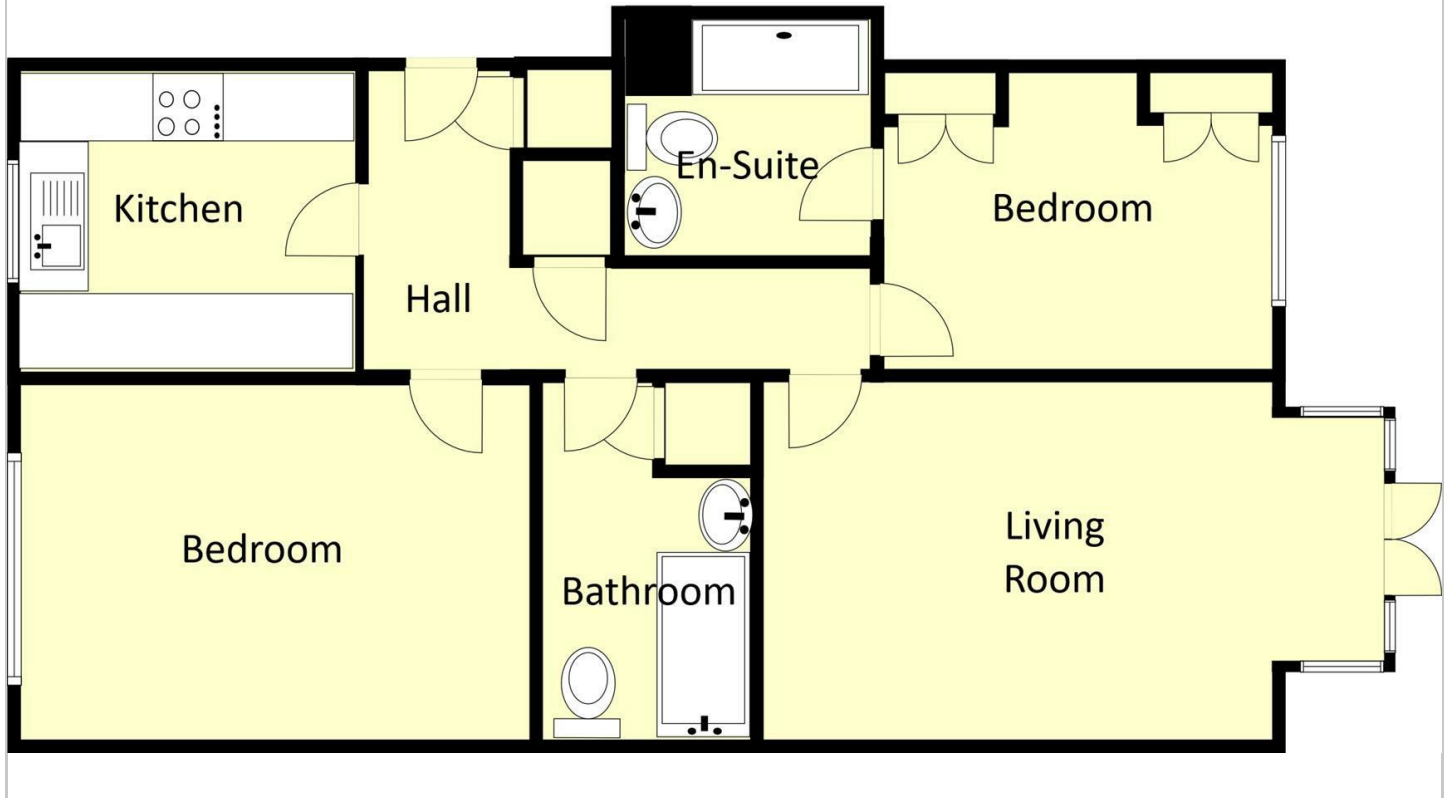

Floor Plan

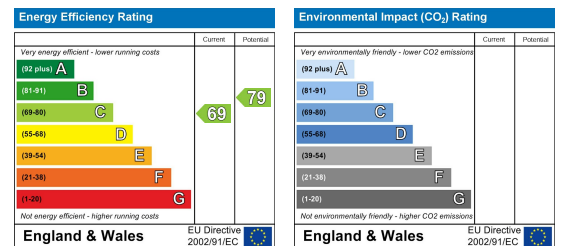
Balmoral Court For Illustrative purposes only, NOT to scale.
