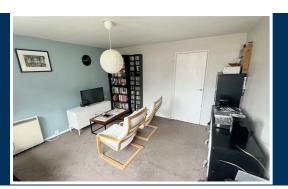

Approach

The property is approached via a communal door opening into communal hallway with stairs giving rise to the second floor accommodation wit front entrance door with opaque window opening into:

Flat Hallway

With lino to flooring, two ceiling light points, wall mounted storage heater, two storage cupboards providing useful storage with one housing the water tank and doors opening into:

Kicthen

With tiled flooring, white wall and base units with wooden work surfaces over incorporating sink and drainer with mixer tap over, integrated 'Hotpoint' electric hob and cooker, space for fridge freezer and washing machine, door opening in useful pantry, ceiling light point and double glazed window overlooking the front aspect.

Living Room

With double glazed window to the rear communal gardens, ceiling light point and wall mounted electric heater.

Bedroom One

12'6" x 13'9" (3.82 x 4.21)

With double glazed windows overlooking the rear communal gardens, wall mounted electric heater and ceiling light point.

Bedroom Two

11'10" x 7'4" (3.62 x 2.24)

With double glazed window to the front aspect and ceiling light point.

Bathroom

8'4" x 4'10" (2.56 x 1.49)

With tiled flooring, tiled walls, three piece white bathroom suite comprising low flush WC, panel bath with mixer tap over and shower attachment above, sink in vanity unit with mixer tap over, double glazed opaque window with extractor fan overlooking the front aspect, ceiling spotlights and wall mounted heated towel rail.

Garage in Separate Block

With metal up and over door.

With parking area, communal gardens, sitting area and pond with a selection of mature trees and hedgerows surround.

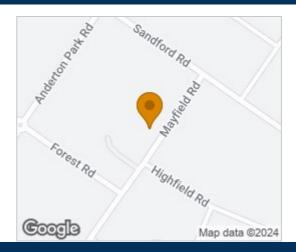




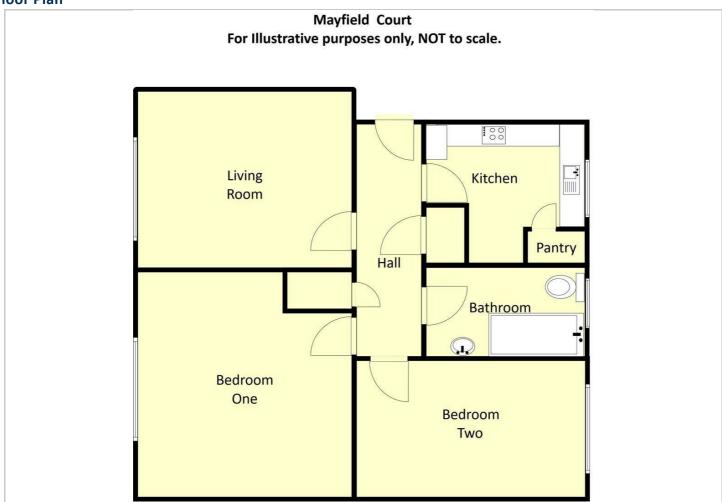








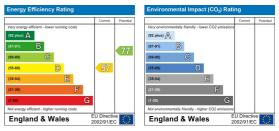
Floor Plan
