



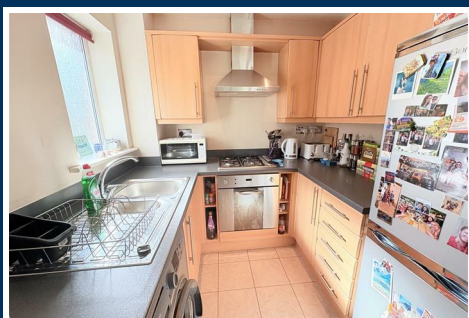

With Laminate wood effect floor covering, ceiling light point, central heating radiator, intercom system, access to loft space (not inspected) and doors opening in to:

Integral gas hob with cooker/grill under and extractor fan over, central heating radiator and double glazed PVC opaque window to the side aspect.

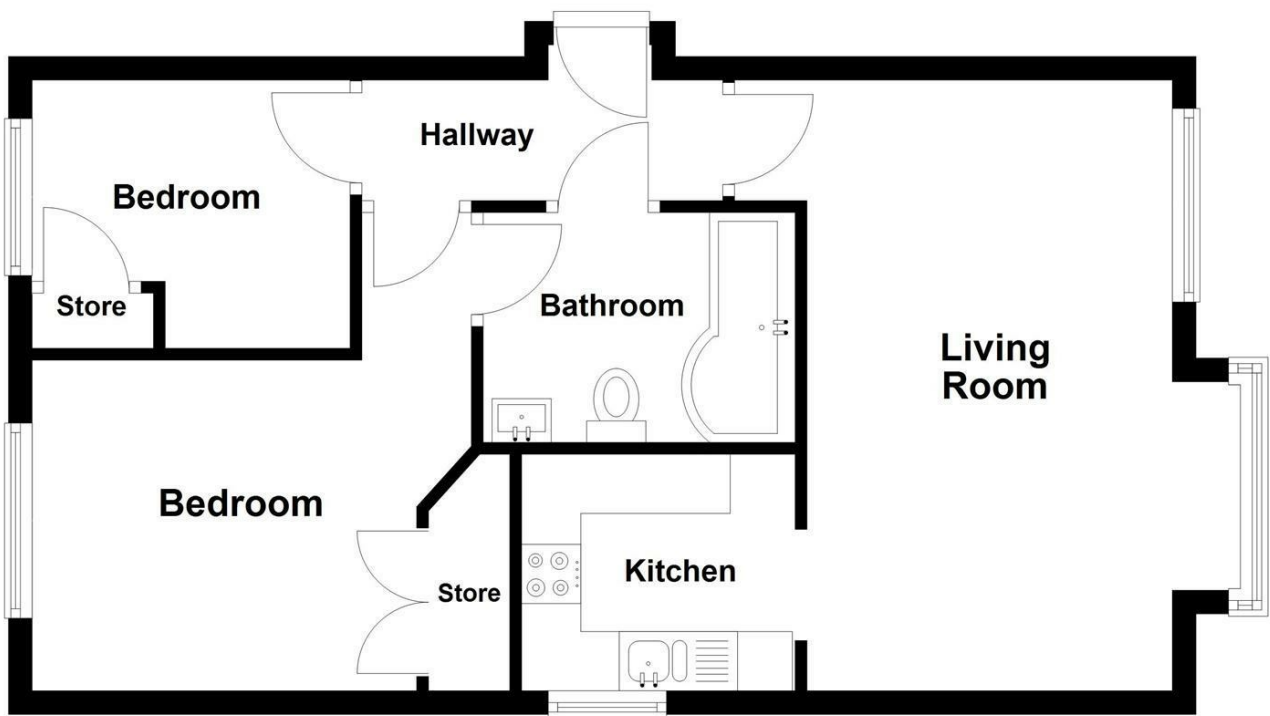

Ground Floor

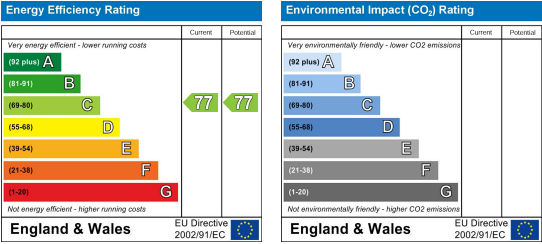
