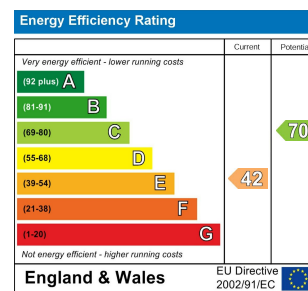
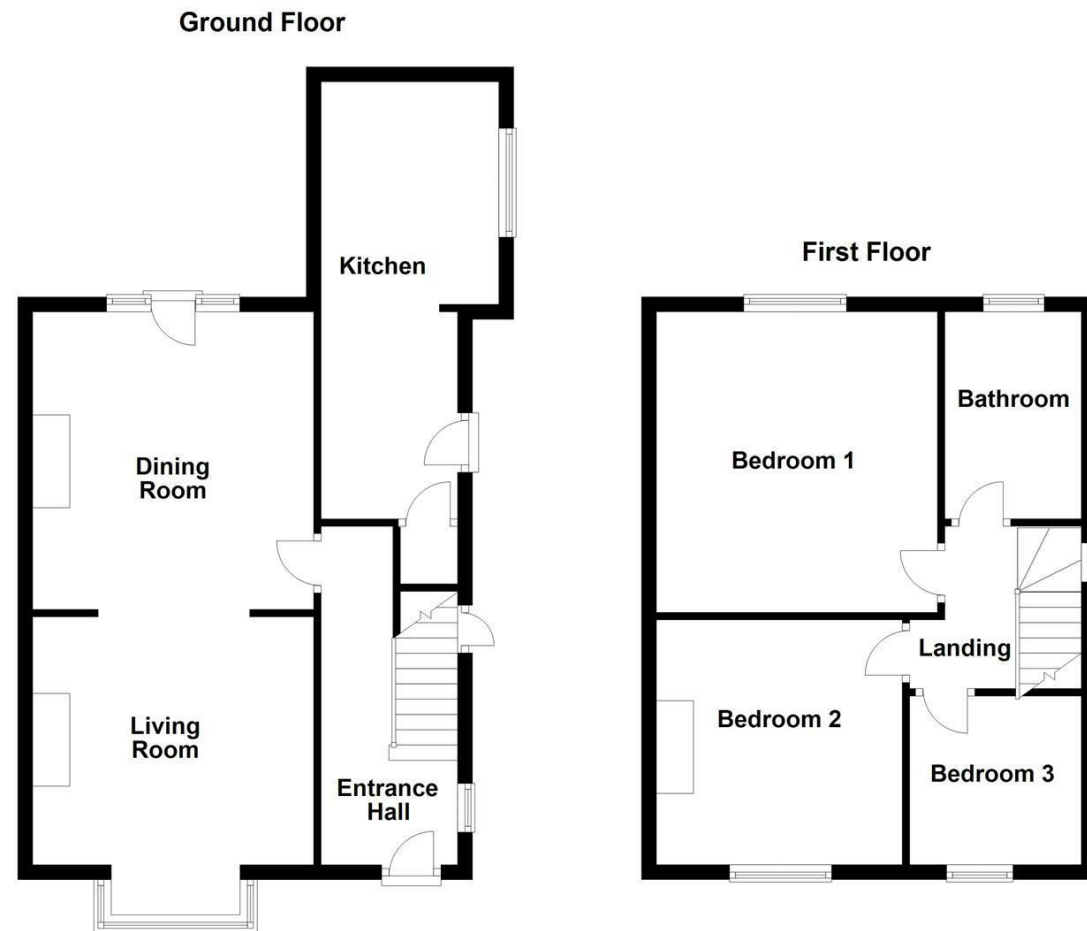

## ACCOMMODATION

### ENTRANCE HALL

Timber framed front entrance door, UPVC double glazed window to the side, coving to the ceiling, stairs to the first floor landing, central heating radiator and doors to the dining room and kitchen.

### DINING ROOM

13'2" x 12'5" [max] x 10'11" [min] [4.03m x 3.8m [max] x 3.34m [min]]

UPVC double glazed rear door, central heating radiator and gas fireplace with stone hearth, exposed stone surround and wooden mantle. An opening through to the living room.



### LIVING ROOM

14'4" x 12'5" [max] x 6'1" [min] [4.38m x 3.8m [max] x 1.86m [min]]

UPVC double glazed box window to the front, coving to the ceiling, central heating radiator and gas fireplace with stone hearth, exposed stone surround and wooden mantle.

### KITCHEN

20'2" x 7'10" [max] x 5'1" [min] [6.15m x 2.39m [max] x 1.55m [min]]

Range of wall and base units with laminate work surface over, 1 1/2 stainless steel sink and drainer with mixer tap, space and plumbing for a washing machine and space for a gas cooker. Access to an understairs storage cupboard, UPVC double glazed door and window to the side and central heating radiator.



### FIRST FLOOR LANDING

UPVC double glazed window to the side, coving to the ceiling, loft access and doors to three bedrooms and the bathroom.

### BEDROOM ONE

UPVC double glazed window to the rear, coving to the ceiling, central heating radiators and fitted wardrobes.



### BEDROOM TWO

UPVC double glazed window to the front, central heating radiator and fitted wardrobes.



### BEDROOM THREE

7'6" x 7'4" [2.31m x 2.26m]

UPVC double glazed window to the front, central heating radiator and coving to the ceiling.

### BATHROOM/W.C.

6'0" x 9'2" [1.84m x 2.81m]

UPVC double glazed frosted window to the rear, coving to the ceiling, central heating radiator, low flush w.c., pedestal wash basin, panelled bath with electric shower head attachment and partially tiled.



### OUTSIDE

To the front of the property there is an iron gate providing access to a paved pathway leading down the side of the property, round to the rear which is paved with raised planted beds and mature shrubs.
