Landing: Store cupboard.

Bedroom: $13' 7'' \times 10' 0'' (4.15m \times 3.06m)$ Upvc double glazed window and radiator.

Bedroom: 14' 2" x 9' 11" (4.31m x 3.02m) Upvc double glazed window and radiator.

Bedroom: 10' 6" x 5' 1" (3.19m x 1.55m) Upvc double glazed window, radiator.

Bathroom: 5' 9" \times 5' 7" (1.75m \times 1.70m) Fully tiled walls and floor, modern suite comprising a panelled bath with a mixer tap shower and screen, pedestal wash hand basin and low flush WC. Radiator, upvc double glazed window.

SECOND FLOOR

Loft Room: 11' 10" \times 10' 6" (3.60m \times 3.21m) Plus eaves storage and alcove space. Ceiling window, radiator, door through to the stairs leadind down to the first floor.

Gardens: Walled front yard with a planted hedge. Concreted rear yard.
